## MATERIAL HANDLING RATES

**Shipments to and from show site: Carriers are required to check in at staging before allowed on the property located at 2494 East Sunrise Boulevard, Fort Lauderdale, FL 33304**

- ◆ ALL SHIPMENTS ARE REQUIRED TO HAVE DOCUMENTED CERTIFIED WEIGHT TICKETS.
- ◆ IF MATERIAL DOES NOT INCLUDE A WEIGHT TICKET, SHOW MANAGEMENT AN INFORMA BUSINESS WILL WEIGH MATERIAL.
- ◆ NO COLLECT SHIPMENTS WILL BE ACCEPTED.
- ◆ RATES ARE BASED ON PER SHIPMENT ON THE INBOUND WEIGHT AND THE DATE/TIME FREIGHT IS RECEIVED.
- ◆ STANDARD RATE WILL APPLY IF FREIGHT AND PAYMENT IS NOT RECEIVED BY THE ADVANCE RATE DEADLINE.

**SHIPMENTS REQUIRING SPECIAL HANDLING** will be handled at the exhibitors risk and will be charged the above published rates plus 50%. Includes, but is not limited to any shipment that is loaded and/or packed in such a manner as to require additional handling, ground loading, side door loading, constricted space loading, designated piece loading, stacked shipment(s) and crates delivered to floating docks weighing in excess of 5,000 lbs each. Includes shipments that are loose and not in crates, cases, boxes, and/or non-skidded machinery without proper lifting bars or hooks.

**OVERTIME RATES** in the amount of 25% of the above mentioned rates will be assessed and applied each way to freight either received at the warehouse or show site that must be moved into or out of booth(s) before 8:00 am or after 4:30 pm Monday to Friday or on Saturday and/or Sunday.

**INSURANCE** It should be clearly understood that Informa Markets US Boat Shows is not an insurer. Each Customer should arrange complete risk coverage for the value of said equipment through endorsements to existing policies, insuring the exhibit material from the time it leaves their facility until it is returned. It should be further understood and agreed that Informa Markets US Boat Show does not provide full liability, should loss or damage occur. Should Informa Markets US Boat Shows incur a liability, it shall be limited to the specific article which is lost or damaged, and in any event, the maximum liability shall be limited to \$0.30c per pound per article with a maximum liability of \$50.00 per item, or \$500.00 per shipment, whichever is less.
